### Zelle®/P2P Fraud Warning

Zelle/P2P fraud is widespread and has been making national news as the tactics used by fraudsters continue to evolve. A newer version of the scam has fraudsters impersonating a Zelle user's financial institution. Caller ID spoofing is when a caller falsifies the information on your caller ID to impersonate someone, like your credit union. If you receive an unexpected call that appears to be from Greenville Heritage FCU, hang up and call us directly at our published number, 864.467.4160. We urge members who enjoy the convenience of Zelle transfers to use extreme caution.
